- 1) I/We understand that *Techno India Agartala*, henceforth to be referred as *TIA* that "Private Tuition" is strictly banned at TIA. Parents and Guardians are advised to inform the TIA authority should anyone approaches to them for this purpose using TIA's name. Parents/Guardians are also advised to approach the TIA authority should the student in question requires any special help academically at any point of time.
- 2) I/We understand that TIA desires and advises the Parents/Guardians to **keep close contact with the authority** to remain updated on the attendance status and academic performance of the students periodically.
- 3) I/We understand that *TIA* allows only *non-political representation* through the selected representatives (by TIA, through merit only) for lodging any complaint/grievances. I/We also understand that should we not follow this process, our claim for any grievances/complaints to any other forum becomes automatically void.
- 4) I/We also understand that as a student of TIA I must not participate in any *mass* demonstration, unrest and/or any other activity which can violate the environment of the TIA campus. My participation to such activities may qualify me to get **punitive action** which includes but not limited to suspension of classes, financial penalty, rights to continue as a student at TIA etc.
- 5) I/We understand that its mandatory to avail the transport provided by the TIA authority by paying the requisite fees per semester basis except for the students needing for special care and/or physically handicapped category for which special vehicle may be needed. Use of personal vehicle including motor bikes with in the campus is not permissible except special exception with reasons.



- 6) I/We understand that **80% attendance is mandatory** for every TIA student. Tutorials ,tests must be duly attended and assignments must be submitted on time without failure. Should any student fail to have 80% attendance, would require to follow special TIA process which may include but not limited to *personal declaration*, *affidavit from the parent/guardian*, *financial penalty* etc. applicable individually and/or collectively following TIA's own frameworks of rules. TIA authority reserves all the right to allow and/or disallow any student from appearing semester examination based on the attendance and performance in the internal tests in order to maintain its high academic standard. I/We understand that in order to maintain and sustain the academic excellence whatsoever the decision is taken by the TIA authority cannot be contested and/or no attempt would be made to alter that .
- 7) I /We understand that **TIA has ZERO tolerance for ragging**. No student must participate in any kind of ragging directly or indirectly. I/We also declare that we shall submit the anti-ragging affidavit per AICTE ,Govt. Of India rules before commencement of the academic session
- 8) I/We understand that the student shall remain responsible for paying the **semester fees on time** following the notification of the TIA authority. Should any student fail to pay fees on time must obtain *special permission* from the HOD (Students' Affair) *before the due date of payment* stating the reason as well as affirming a fixed date of payment. This is also understood that non-payment of fees within the due and/or extended dates would require fines and beyond a certain date TIA authority will reserve all the rights to suspend the student from attending the classes as well as debarring the student from attending all the tests and examinations including the semester examinations conducted by the affiliating Tripura University.
- 9) I/we understand that TIA is keen to **preserve its academic and professional excellence** to remain competitive in the market place. All the students in TIA must adhere to use the TIA's own designed and prescribed materials for the lab and workshop purpose.
- 10) I/we understand that the students need to participate TIA conducted GATE-Prep and/or similar events which include but not limited to short term professional courses, web based assignments and testing, Prep classes for PO/SSC and/or similar exams etc. which are built to prepare the candidates for the competitive examinations. Should a parent/guardian/student wishes to skip such programs would automatically waive the right for participating TIA sponsored job events and shall not blame TIA for any failure.
